## Agreement to Hold Harmless, To Indemnify and Release from Liability

In consideration for the privilege of engaging in recreational activities in conjunction with the GOTAHams Get on the Air Hams Amateur Radio Club (GOTAHams), I hereby agree and understand that:

There are inherent risks involved, including the risk of serious physical injury or death, in participating in the types of activities conducted by GOTAHams members at GOTAHams events. I also understand that these activities may take place at various public parks or other public venues or within restaurants and businesses and that my use of GOTAHams equipment or member's equipment exposes me to these inherent risks, whether I am participating in any activities or not. With the understanding of the risks involved I fully assume all risks associated with my presence at GOTAHams events or use of GOTAHams or member's equipment even if such risks are due to the negligence of the GOTAHams, its Officers, Directors, Members, Agents, Employees or any other person, including but not limited to the handling and transportation of electronic equipment, cables, antennas, tools, organized training or operating events, GOTAHams meetings and social gatherings, lack or inadequacy of warnings, lack or inadequacy of safety devices, lack or inadequacy of instructions and any use of equipment.

I, for myself and for my heirs, successors, executors, administrators, legal representatives and assigns or anyone claiming a right through me, agree I will defend, indemnify and hold harmless the GOTAHams, it's Officers, Directors, Members and Agents from any and all claims, suits, demands, causes of action or claimed causes of action by anyone arising from or in connection with my participation in GOTAHams events or use of GOTAHams or member property including claims of negligence on the part of the GOTAHams, its Officers, Directors, Members and Agents.

I, for myself and for my heirs, successors, executors, administrators, legal representatives, assigns or anyone claiming a right through me, hereby release and agree that I will not sue the GOTAHams, its Officers, Directors, Members, Agents and Employees for money damages for personal injury or property damage sustained by me while engaging in recreational or any other activity at GOTAHams events even if due to the negligence of the GOTAHams, its Officers, Directors, Members and Agents.

I understand that recreational activities shall mean any participation at GOTAHams events or use of GOTAHams or Member property including but not limited to socializing as well as assembling, operating, repairing, erecting, connecting, transporting, carrying, walking amidst, disassembling, and/or permitting the use by others of Amateur Radio related equipment and antennas.

I have read this Agreement and fully understand its terms. I further understand that by signing this Agreement I am giving up substantial legal rights. I have not been induced to sign this Agreement by any promise or representation and I sign it voluntarily and of my own free will.

If I am less than eighteen years of age, the person signing on my behalf is my legal guardian, certifies that they are the legal guardian of the Applicant, has read this Agreement and fully understands its terms, and by signing this Agreement has given up substantial legal rights of mine.
